## A. Winter/ Summer Program (Including Off-site Teaching Program)

- 1. Participating in overseas institution's winter or summer program during YZU's winter or summer break.
- 2. Excluding travel days and free activities, actual academic exchanges and visits are either 10 days or more or fewer.
- 3. Not applicable for students receiving "MOE Study Abroad Scholarship" or ground reception provided by the host institution.
- 4. No subsidy for accompanying teachers.

## B. Short-Term Exchanges/International Overseas Volunteer Programs

- 1. Short-term exchanges involve academic exchanges and visits abroad during the semester
- 2. Academic exchanges during short-term exchanges must account for more than half of the total itinerary.
- 3. Presenting papers abroad, attending international conferences, and ground reception provided by the host institution are not applicable for this subsidy.
- 4. International volunteer work overseas follows the definition provided by the Office of Student Affairs, but service must be provided at academic institutions equivalent to or higher than high schools.

5. No subsidy for accompanying teachers.

## C. Overseas Internships

- 1. Three subsidy principles for year 2025:
  - I. Those who have officially applied for the MOE "Study Abroad Scholarship" and received subsidies are not eligible for this project's subsidies.
  - II. Those who have officially applied for the MOE "Study Abroad Scholarship" but have not received subsidies are eligible for the maximum distribution standard of this project's "Overseas Internship" subsidy.
  - III. Those who have not officially applied for the MOE "Study Abroad Scholarship" are eligible for up to 40% of the distribution standard of this project's "Overseas Internship" subsidy.
- 2. Overseas internship period must be at least 320 hours, with a principle of continuous internship for 8 weeks or more.
- 3. Paid internships are not eligible for this subsidy
