## Yuan Ze University Regulations of Study Abroad Scholarship

Passed at the 19th Administrative Meeting of 2002 dated Jul. 14, 2003 Revised and passed at the 5th Administrative Meeting of 2005 dated Nov. 7, 2005 Revised and passed at the 18th Administrative Meeting of 2005 dated May 22, 2006 Revised and passed at the 6th Administrative Meeting of 2009 dated Dec. 7, 2009 Revised and passed at the 9th Administrative Meeting of 2009 dated Mar. 3, 2010 Revised and passed at the 17th Administrative Meeting of 2015 dated Apr. 27, 2016

Article 1 To enhance students' international perspectives and promote mutual benefits through international and cross-strait exchange activities, and to help students grow and increase the visibility of the university on the international stage, this regulation is hereby established to promote mutual benefits.

Article 2 The activities referred to in this regulation are as follows:

- 1. Taking credit courses abroad or pursuing a dual degree at a foreign university that adheres to the implementation guidelines for YZU students taking courses abroad and submitting an application to the Office of Academic Affairs.
- 2. International and cross-strait intercollegiate exchange activities, or exchange activities between international and cross-strait universities and institutions, include participation in international workshops and leading a delegation in intercollegiate exchange activities.

Article 3 The scholarship eligibility is as follows:

- 1. Students who hold the nationality of the Republic of China (Taiwan).
- 2. Outstanding students recommended by various colleges and administrative units.

Article 4 The funding subsidy principles are as follows:

- 1. Scholarships shall be prioritized in the following order: dual-degree programs or credit courses at foreign universities, international and cross-strait intercollegiate exchange activities.
- 2. Pursuing a dual degree or taking formal credit courses should be limited to those with formal contracts or approved by the university's project; international and cross-strait exchange activities should have relevant supporting documents.
- 3. The principle is that students receive one subsidy per academic year during their period of study.
- 4. This scholarship is not available to applicants who receive full subsidies from other universities/institutions/agencies regarding the same case. Subsidies will be recovered in full if found.
- 5. The number of scholarship recipients and the amount of scholarship may be adjusted flexibly according to the budget for the academic year.

Article 5 The application procedure shall include the following materials submitted to the responsible unit:

- 1. Application form.
- 2. Specific content of international and cross-strait exchange activities, including activity name, content,

time, location, and expected outcomes.

- 3. Other supporting information.
- Article 6 Scholarship applications shall be reviewed by the responsible unit.
- Article 7 If the approved international and cross-strait exchange activities are changed, delayed or canceled due to unforeseen circumstances, students shall inform the responsible unit in advance.
  If there are any disputes, they will be handled by the unit in charge.
- Article 8 This regulation shall be implemented after being passed by the administrative meeting, and shall be amended accordingly.

In case of discrepancy between the Chinese version and the English version, the Chinese version shall prevail.
